NOTIFICATION

It is notified that the following amendments to Ordinance 20 of Chapter V 'Degree Certificates and Mark lists' of the Kannur University Ordinances, 1999 passed by the Syndicate at its meeting held on 17/01/2017 and Ordinance 3(1) of Chapter XV-'The scale pay, age etc. for non-teaching posts' passed by the Syndicate at its meeting held on 03/05/2019 have been assented to by the Chancellor on 01/11/2019.

The amendments to Ordinances shall be deemed to have come in to force with effect from 01/11/2019.

Amendment No. 1

Amendment to Ordinance 20 of Chapter V - Degree Certificates and Mark lists' of the Kannur University Ordinances, 1999.

That the existing provision in Ordinance 20 'Degree Certificates and Mark lists' in the Chapter V of the Kannur University Ordinances, 1999 is amended as follows.

Chapter V Ordinance 20

Degree Certificates and Mark lists A Degree under the seal of the University and signed by the Vice Chancellor shall be issued to each successful candidate at examination for a degree. The degree shall set forth the month and year of the examination, the subject in which the candidate was examined, the class in which he was placed and the subjects which he gained distinction, if any. A mark list signed by the Controller of Examinations, shall be given to each successful candidate at an examination. The mark list shall set forth the month and year of the examination, the subjects in which the candidate was

Chapter V Ordinance 20

Degree Certificates and Mark lists A Degree under the seal of the University and signed by the Vice Chancellor either manually digitally shall be issued to each successful candidate at an examination for a degree. The degree shall set forth the month and year examination, the subject in which the candidate was examined, the class in which he was placed and the subjects in which he gained distinction, if any. A mark list signed by the Controller of Examinations, shall be given to each successful candidate at examination. The mark list shall forth the month and year of the examination, the subjects in which the

A certificate signed by the Controller of Examinations shall also be given to candidates whose original Degrees, Diplomas have been irrecoverably lost or destroyed.

Provided that it shall be competent for the University to issue a provisional Certificate to a candidate on payment of the prescribed fee during the period after publication of the results in the University Office and before the issue of the Original Certificate.
