NOTIFICATION

It is notified that the following amendments to Ordinance 3(1) of Chapter XV 'The Scale of pay, age, etc. for non-teaching posts' of the Kannur University Ordinances 1999 (post no.28, 30 & 38 in the schedule) passed by the Syndicate at its meeting held on 12/03/2018, 13/04/2018 and 09/02/2018 respectively have been assented to by the Chancellor on 26.06.2020

The amendments to Ordinances shall be deemed to have come in to force with effect from 26.06.2020

Amendment to Ordinance 3(1) of Chapter XV - 'The Scale of pay, age, etc. for non-teaching posts' of the Kannur University Ordinances, 1999.
