
These amendments to ordinance shall be deemed to have come into force with effect from 01/06/2021.

Amendment to ordinance 1 'Appointment of Examiners and question paper setters' of Chapter IV – Appointment of Examiners and Question Paper Setters- of the Kannur University Ordinances, 1999.

That, a new sub clause (3) is inserted immediately after sub clause (2) under ordinance 1 – 'Appointment of Examiners and question paper setters' of Chapter IV – Appointment of Examiners and Question Paper Setters, as follows.

the conduct of examinations, the Controller of Examinations may, in view of urgency, appoint qualified examiners from the Teachers Index prepared by the University or from the panel submitted by the Board of Studies or from the panel of teachers submitted by the Chairman of Board of Examiners, and such action shall be reported to the Vice Chancellor thereafter.
