ORDER

1. As per the paper read (1) above, Students belongs to the category of deaf (hearing impaired) dumb, blind, spastic and dyslexic in Affiliated colleges and the Teaching Departments of the University were exempted from studying additional/ second language.
2. Consequent to the implementation of FYUGP w e f 2004 admission, the Principal, Mar Thoma College for the Hearing Impaired vide paper read (2) above, has raised concern, whether the Hearing impaired students will continue to get the aforesaid exemption.
3. Considering the matter, the Vice Chancellor has ordered to place the matter of giving concession of Ability Enhancement course to the Hearing impaired students under FYUGP, before the consideration of the Academic Council.
4. XXVIII th meeting of Academic Council held on 25/06/2024 considered the matter and resolved to refer the matter to the Standing Committee of Academic Council for detailed study (vide paper read 3 above)
5. Subsequently, the Standing Committee of the Academic Council, vide paper read 4 above, considered the matter and referred it to the Academic Council. The recommendation of the Standing Committee of the Academic Council was approved by the Vice Chancellor.
6. Meanwhile, in the review meeting of FYUGP, organized by Kerala State Higher Education Department at CUSAT on 21.10.2024, it was resolved to continue the existing exemption of Additional language to the Hearing Impaired students in AEC course of FYUGP also. (paper read 5)
7. The XXIXth meeting of the Academic Council considered the matter of giving existing concession on Ability enhancement course (AEC) to the hearing impaired students under FYUGP and approved it.
8. The minutes of the meeting of the Academic Council was approved.
9. Therefore, in view of the resolution of the Academic Council, ***it is ordered that the existing practice of relaxation of Additional language for hearing impaired students shall continue in the AEC (i.e, AEC2 & AEC4) courses of FYUGP also.***


