Scheme & Syllabus of BSW programme- Modified for 2020 Admission only to fix the total credit of the Programme as 120 by relaxing Clause 4.8 & 5.3 of the U.G Regulation 2019 in Affiliated Colleges - Implemented- Orders issued.

ORDER

1. The Revised Regulation for UG programmes in Affiliated Colleges under Choice Based Credit and Semester System (in OBE-Outcome Based Education) was implemented with effect from 2019 Admission vide paper read (1) above.

2. As per **Clause 4.8 of the UG regulation, for passing the degree programme the student shall be required to achieve a minimum of 120 credits. In the case of LRP programmes this 120 credits is distributed as 14 credits for common English Courses, 8 credits for Additional common courses and 16 credits for General awareness courses. Minimum credits required for core, complementary elective and Generic Elective courses put together are 82. However the credits to be set apart for the core and complementary elective courses shall be decided by the Board of Studies concerned. The maximum credits for course shall not exceed 5.**

3. Subsequently, the Scheme and Syllabus of Core, Complementary elective & Generic Elective courses of BSW programme were prepared by BoS in Social Work in line with U.G .Regulation by fixing the credits as follows

Complementary Elective Courses -Total credit=16

Generic Elective Courses - Total credit= 2

Core Courses - -Total Credits = 64

Total credits for Core + Complementary +General elective = 82. This was implemented w.e.f. 2019 admission vide Paper read to 2 above..

4. Since the syllabus of Complementary Elective courses for BSW Programme (Psychology & Sociology) were prepared by the Board of Studies in Social Work (Cd), this was made applicable to 2019 admission only and ordered (vide paper read 3 above) to adopt the Syllabus of the Complementary Elective courses prepared by the respective Board of studies (Psychology & Sociology) w.e,f 2020 admission onwards.

5. The Examination Branch, while finalising the VI semester Examination results of 2020 admission pointed out that (paper 4 above) the **BSW Regulation for 2020 Admission deviate from the common U.G. Regulation as the credit given to complementary elective course - Psychology is 6 (1CO9 PSY & 2C10PSY, having 3 credits each) and hence the total credits for Complementary courses become 14 instead of 16 and total credits of the entire BSW Programme become 118 instead of 120. Therefore, Examination Branch seeks clarification in this regard.**

6. Subsequently, in the circumstance of non-existence of Board of studies, clarification was sought vide Paper read 5 above, from Dr. Anish K.R, the former Chairman, Board of Studies in Social Work (Cd), to resolve this issue,

7. Dr. Anish K.R, the former Chairman, Board of Studies in Social Work (Cd), vide Paper read 6 above, **suggested to distribute the additional 2 credits to 6B16BSW - Core courses XVI Field Work of the sixth semester of BSW Programme for 2020 admission only to fix the total credit of the Programme 120 as the results up to First to Fifth semesters has already been published .**

8. **The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11(I) Chapter III of Kannur University Act 1996 , accorded sanction to to fix the total credit of BSW Programme as 120 by altering the credit distribution in the sixth semester BSW programme by adding two credits to the core course, 6B16BSW - Core courses XVI Field work) for 2020 admission only by relaxing Clause 4.8 & 5.3 of the Regulation for UG Programmes and scheme part of BSW**

Regulation implemented in Affiliated Colleges w.e.f.2019 admission as detailed in para (3) above subject to reporting before the Academic Council.

9. The modified pages of the Syllabus are appended herewith.

10. U.O. read (2) above stands modified to this extent for 2020 admission only.
