As per the paper read first above the meeting of the Head of the Departments/Course Directors/Course Co-ordinators of the University Teaching Departments held on 22/02/2010 considered the draft rules for admission to P.G Programmes at the University Teaching Departments with effect from 2010 admission onwards and finalised the same for approval by the Syndicate.

As per the paper read second above the Syndicate, considered the minutes of the meeting of the Head of the Department read first above and resolved to authorize the Vice Chancellor to take appropriate decision.

The Vice Chancellor after considering the matter in detail, has approved the draft rules for admission to P.G Programmes offered at the University Teaching Departments effective from the academic year 2010-11 onwards for implementation.



Admission Rules with effect from 2010 admissions

1. Admission to P.G Programmes offered at the teaching departments of Life Science and Information Technology shall be based on

i) Entrance Examination and ii) Personal Interview (PI)

In the case of admission to MBA Programme, there shall be Group Discussion (GD) also apart from the above 2 components.

Admission to M.A Music shall be based on marks secured at the qualifying examinations (50%) and aptitude test (50%).

Admission to the courses offered at the other departments shall be based on the marks secured at the qualifying examinations (50%) and entrance test (50%).

(Entrance exam will be held when the number of applicants are three times or more than the sanctioned strength; otherwise admission will be based on merit.)

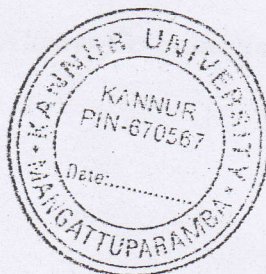
2. It shall be the responsibility of the Heads of the respective teaching departments/Department Council to get the entrance examination question paper set and to get it printed, maintaining strict confidentiality in this regard.
3. It shall be the responsibility of the Heads of the respective teaching departments/ Department Council to conduct the entrance examination on the scheduled date, to arrange valuation of the answer sheets/scripts, and to publish the results in time.
4. Entrance Examination shall be of duration of minimum 90 minutes. The details shall be worked out by the Department Council, communicated to the University and incorporated into the prospectus.
5. Candidates seeking admission to P.G Programme should have scored a minimum of 50 percent marks in the qualifying examination. But in the case of candidates belonging to backward communities, the minimum eligibility cut off marks is 45%. Candidates belonging to SC/ST category who have passed the qualifying examination are eligible to apply for admission to P.G Programme.
6. Remuneration payable to question paper setters and valuers shall be Rs.20/- for each question and Rs.5/- for each answer script/answer sheet valued.
7. Remuneration payable to the invigilators of the entrance examination shall be as per the existing University rules pertaining to other University Examinations.

8. The weightage marks given to candidates holding NSS/NCC certificates shall be 0.3% marks in addition to their total index marks.
9. All candidates undergoing their final year degree course/who have completed their course are those awaiting their final year degree results are eligible to apply for admission to P.G Programme.
10. The application fee for admission shall be Rs.500/- for Information Technology, MBA and Life Sciences; and Rs.250/- for other courses for all candidates, except those belonging to SC/St categories, in whose case, the application fee shall be Rs.100/- only.
11. The following shall be the rules of reservation of seats in admission for P.G Programmes in the University departments.

12. Schedule of various stages of Admission Process.

- a. Release of common Admission notification in prominent print Media
(All editions across the State of Kerala) : Second week of April every year.
- b. Conduct of Entrance Exam : Before 15th May every year.
- c. Publication of Rank List : Before 15th June every year.
- d. Admission of students : Before 30th June every year.
- e. Commencement of I Semester classes : Before 10th July every year.

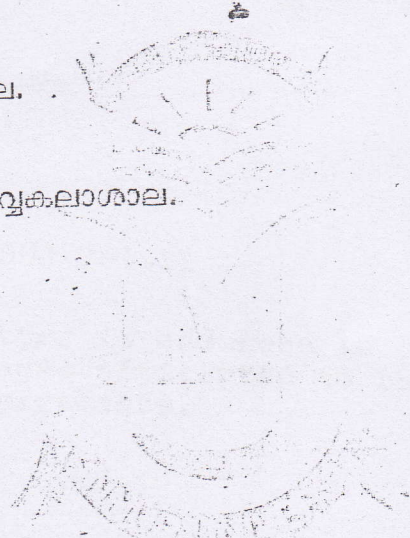




