**ORDER**

1. The scheme and syllabus of BSW programme was modified for 2020 admission only vide Paper read (2), to fix the total credit of the programme as 120 by relaxing the clause 4.8 & 5.3 of the UG regulation 2019 in Affiliated Colleges (Paper read 1), as there was shortage in two credits in the complementary courses of Psychology.
2. The Examination Branch reported that, the same condition exist in 2021, 2022 & 2023 admissions also and requested to rectify the defect.
3. Subsequently, as ordered, clarification was sought vide paper read (3) above from the Chairperson, BoS in Social work (cd) and the Chairperson recommended that, "as the students have already completed their first and second semester study of the programme, it is beneficial that relaxation may be applicable to 2021, 2022, 2023 admissions" (paper read 3)
4. The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic council conferred under Section 11(1) Chapter III of Kannur University Act 1996 **approved the aforementioned remarks furnished by the Chairperson and ordered to make applicable the relaxation of Clause 4.8 & 5.3 of the 2019 UG regulation in Affiliated Colleges provided vide paper read (2) above to 2021, 2022 & 2023 admissions of BSW Programme.**
- 5.The U.O read as paper (1) above stands modified to this effect.
- 6.Orders are issued accordingly.
