# Scope of Work

## II. Eligibility criteria

The Contractor/Agency/Special Agency/consultant should fulfil the following eligibility criteria (Proof of each to be submitted)

- i. The Contractor/Agency/Special Agency/consultant should be registered in India with office in Kerala having experience for the last 5years in the similar nature of works. Proof by production of certificate /copy of agreement from client to be submitted along with offer.
- ii. The Contractor/Agency/Special Agency/consultant should have valid PAN Number.
- iii. The Contractor/Agency/Special Agency/consultant should also have GST registration certificate.
- iv. The Contractor/Agency/Special Agency/consultant should furnish a self certified undertaking to the effect that they have not been black listed in India by any government department/Agency/Special Agency/consultant in last 5years.

## III. Execution of Agreement

#### VI. Visit to Site

The Contractor/Agency/Special Agency/consultant before submitting Expression of Interest for the work shall ensure that, they have visited the Site and satisfied about the site conditions for the work and for logistics and smooth flow of work men, and materials as well as permission from Authorities for this purpose.

The travelling expenses to Kannur University Office and the project sites by Agency / consultant/ Special Agency /consultants or their representatives to be engaged by The Agency/consultant, shall be borne by the Agency/consultant themselves.

## VII. General Conditions

- i. The financial bids for 5 lifts in one cover and Technical bid in another cover shall be submitted.
- ii. Incomplete, late, and conditional offers will be summarily rejected. Tenders with AMC rate quoted for all the 5 lifts only will be considered..
- iii. Registrar, Kannur University reserves the right to reject any or all the offers without any reason whatsoever.
- iv. The Contractor /Agency /Special Agency/ consultant should fulfil the above mentioned eligibility criteria (proof of each to be submitted).
- v. Validity of offer:-The offer for Expression of Interest (EOI) shall be valid for a period of three months from the date of opening of the offer and on special case the same will be extended further if mutually agreed.

#### IX. Evaluation Process and Criteria

A two-stage evaluation procedure will be adopted for evaluating the proposals for selection of bidders. The bidder shall submit both technical bid and financial bid in separate sealed covers. The financial bids shall be opened only after completing the evaluation of the technical proposal. University will follow the Quality & Cost Based Selection (QCBS). The weightages as signed for the technical and financial proposals will be in the ratio of 70:30.

## A. Technical Bid Evaluation

- i. The bidders must meet all the prequalification criteria stated in Annexure I. The bidders who meet all the prequalification criteria will be invited to conduct a technical presentation of the project proposal submitted with the Expression of Interest (EOI).
- ii. It is the responsibility of applicants to provide all supporting documents necessary to fulfil the mandatory eligibility criteria. In case, information required by Kannur University is not provided by the applicant, Kannur University shall proceed with evaluation based on information provided by the applicant.
- iii. Kannur University's evaluation committee shall evaluate the Technical Proposal (Documents and Presentation) on the basis of their responsiveness to the Terms of Reference and the Expression of Interest, applying the evaluation criteria and sub-criteria. A proposal shall be rejected at this stage if it does not respond to important aspects of the Expression of Interest.
- iv. Technical bid Evaluation will be based on the following criteria

## B. Financial Bid

- i. The Financial Bids of the shortlisted bidders will be opened by the Registrar or his/her authorized representative. The bidders will get a message on the financial bid opening date and time prior to the scheduled opening. These Financial bids shall be then opened, and the prices recorded.
- ii. The Bidder is deemed to have included all prices in the financial bid, so neither arithmetical corrections nor price adjustments shall be made. The total price, including taxes, specified in the Financial Bids shall be considered as the offered price.
- iii. Evaluation of Price Bid: The total cost including all applicable taxes as quoted by the bidders will be compared. The bids will be awarded a financial score (FBS). The bid with lowest total cost (L1 bid) will be awarded 100% FBS (considered as base value). Then the other bids will be awarded FBS inversely proportional to their bid value. Thus the L1 bid will have the greatest FBS and the H1 (highest bid) will have least FBS.
- iv. Overall Evaluation of Bid: The overall evaluation of bids shall be done using QCBS model. The Final Score (FS) shall be calculated based on the formula;  $FS = [TBS \times 70\% + FBS \times 30\%]$ .
