ORDER

1. University orders were issued vide paper read (1) granting extension of time to Ph.D. scholars for submission of final thesis in the wake of Covid -19 pandemic and the benefit was extended upto 31.12.2021 vide paper read (2) in the light of UGC's Public notice dated 03.01.2021. Extension of time upto 31.12.2021 was also granted to all Ph.D. Scholars to continue research and to submit final thesis with the existing research supervisors, who retired from service in view of Covid-19 disruptions.

2. As per the Public Notice read (3) above, UGC has intimated that in continuation of UGC public notice dated 16th March 2021 regarding extension of date for submission of thesis for terminal M.Phil / Ph.D. Students, and keeping in view the larger interest of research scholars, a further extension of six months beyond 31.12.2021, i.e. till 30.06.2022, for the submission thesis by M.Phil. / Ph.D. students may be granted by the Universities. It is also notified that the extension for submission of M.Phil. / Ph.D. thesis till, June 2022 shall be applicable to all such students whose due date of submission of M.Phil. / Ph.D. thesis is on or before 30.06.2022. Extension of six months may also be granted for submitting evidence of publication and presentation in two conferences. However, tenure of fellowship will remain up to five years only.

3. Syndicate of the University in its meeting held on 14.12.2021, resolved vide paper read (4) to grant extension to all research scholars for submitting Ph.D. Final thesis upto 30 June 2022 under the existing guidelines due to Covid-19 pandemic. The resolution of the Syndicate has been implemented as per the powers vested vide paper read (5).

4. Considering the matter, sanction has been accorded by the Vice Chancellor to

1. Grant a further extension of six months beyond 31.12.2021 ie till **30.06.2022** for the submission of final thesis by Ph.D. scholars, whose date of submission of Ph.D. thesis is on or before 30.06.2022, with the conditions as allowed in the UGC public notice read as (3) above.
2. Grant extension of time upto **30.06.2022** to all Ph.D. Scholars to continue research and to submit their final thesis with the existing research supervisors, who retired from service, in view of Covid-19 pandemic

5. Research scholars coming under the purview of this order need not submit individual requests for extension and such requests will not be entertained.
6. U O`s read (1) & (2) above stands modified to this extent.
7. Orders are issued accordingly.


