ORDER

1. As per paper read (1) above, Kannur University FYUGP Regulations and Curriculum Framework, 2024 was approved and implemented in Affiliated Colleges under the University w.e.f. 2024 admission and certain modifications were effected thereafter vide paper read 2.

2. The Examination Branch vide paper read (3) above pointed out the ambiguity in the table, showing the conversion of percentage of marks into letter grade and grade point, depicted in the clause 22.2 of the Regulation as it is silent about the position of candidate scoring 85%, 75%, 65%, 55%, 45% and 35%.

3. Subsequently, the matter was intimated the Chairperson, Curriculum Regulation Committee of FYUGP and the Chairperson forwarded the modified grading table for FYUGP mark conversion by incorporating the candidates scored 85%,75%, 65%, 55%, 45% and 35% in the table, for approval. Further he has requested to modify the clause 3.30 of KUFYUGP Regulation.

4. As per the clause 3.30 of approved regulation, " Each Board of Studies (BoS) shall identify specific courses or basket of courses designed by other Boards of Studies towards minor course credits. Students shall have the option to choose courses from disciplinary/interdisciplinary minors and skill based courses related to a chosen vocational education programme." He requested to modify the clause as " Each Board of Studies shall prepare a basket of Discipline Specific Courses from which the students can choose freely, their major and minor courses according to their requirements and competence."

5. The Vice-Chancellor, after considering the matter in detail and in exercising the powers of the Academic Council conferred under Section 11 (i) Chapter III of Kannur University Act 1996 and other enabling provisions read together with, *approved the modifications in the grading table* (*in Clause 22.2*) and Clause3.30 of FYUGP Regulation proposed by the Chairperson, FYUGP curriculum Regulation committee and accorded sanction to modify the Regulation accordingly, subject to report to Academic Council.

6. Therefore, the clause 3.30 of the KU FYUGP Regulation in Affiliated colleges is modified as " Each Board of Studies shall prepare a basket of Discipline Specific Courses from which the students can choose freely, their major and minor courses according to their requirements and competence.".

7. The modified table for conversion of percentage of marks into letter grade and grade

point, is appended with this U.O
