3. HoD, School of Pedagogical Sciences was requested to offer necessary clarifications in this regard, as per paper read (4) above,

As per paper read (5) above, HoD, School of Pedagogical Sciences submitted the Scheme and syllabus of Specialisation Course "Advanced Methodology and Pedagogy of Optional subjects" in Third semester of MEd programme w.e.f. 2020 admission, after modifying the Course Code MEDNP03C01 to 07 as MEDNP03C12.1 to 7.

The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11 (1) Chapter III of Kannur University Act 1996, accorded sanction to modify the course code of Specialisation Course "Advanced Methodology and Pedagogy of Optional subjects" in Third semester for M.Ed. programme [CBCSS] in the School of Pedagogical Sciences, with effect from 2020 admission, as detailed in para 4 above, subject to reporting to the Academic Council.
