ORDER

- 1.The Regulations for Post Graduate Programmes under Choice Based Credit Semester System in the Schools/Departments of Kannur University were implemented w.e.f 2020 admission as per paper read (1) above and Clauses 6.2 & 6.8 of the same were modified w.e.f 2021 admission as per paper read (2) above.
- 2. Clause 6.11 of the Regulations for Post Graduate Programmes under Choice Based Credit Semester System in the Schools/Departments of Kannur University implemented w.e.f 2020 admission and modified w.e.f 2021 admission states that "The intake, eligibility, admission procedure, curriculum and syllabus for the programmes like MBA/MCA/MEd/MPEd/Law shall be governed by the existing norms and regulations of regulatory external bodies such as AICTE, NCTE, Bar Council etc. However, in case the regulatory body does not specify on any of the above aspects, it should be as per the current regulation".
- 3. As per paper read (3) above, the meeting convened on 27.12.2022 with the teachers from the Department of Management Studies and the officials from Academic and Examination Branches resolved to issue a University Order by Academic Branch, stating that "for Programmes like MBA, M.C.A, M. Ed, M. P. Ed, L.L.M etc. run in the University Teaching Depts., Regulation of apex bodies like AICTE, NCTE, BCI etc. is applicable".
- 4. The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1), Chapter III of Kannur University Act 1996, accorded sanction to modify Clause 6.11 of the Regulations for Post Graduate Programmes under Choice Based Credit Semester System in the Schools/Departments of Kannur University implemented w.e.f 2020 admission and modified w.e.f 2021 admission, as "the intake, eligibility, admission procedure, curriculum and syllabus for programmes like M.C.A/ M.Ed/ M.P.Ed/ Law shall be governed by the existing norms and regulations of the regulatory external bodies such as AICTE, NCTE, Bar Council etc., However, in case the regulatory body does not specify any of the aspects, it should be as per the current regulation. For MBA programme, Regulation of apex body AICTE, shall be applicable", and to report the same to Academic Council.
- 5. UOs read vide paper (1) & (2) above stand modified to this extent.
