NOTIFICATION

The Senate of Kannur University has been reconstituted as per Notification No.ELC/ELC I/4019/2023 dated 23-02-2024 specifying that the names of members to be elected/nominated shown as 'vacant' in the notification will be notified later, after elections/nominations are completed.

Further, the members, nominated by Hon'ble Chancellor under the headings 'Ex-Officio Members' and the elected members of the General Council of University Union of Section 19 of Kannur University Act 1996, were included in the reconstituted Senate as per Notification No. ELC/ELC I/4019/2023 dated 11.06.2024.

As the period of elected members under 19(xi) is for 1 year from the date of election, it has become necessary to conduct election in the constituency of General Council of University Union and vide notification no. ELC/ELCII/9751/2025 dated 26.07.2025 notification was issued with regard to the conduct of election.

The elections to the Senate by the members of the General Council of the University Union from among full-time students were completed and the results declared on 26.09.2025


