5. The Vice Chancellor ordered to place the above Syllabus before the consideration of the Academic Council (paper read (5) above)

6. XXVIII th Meeting of the Academic Council held on 25-06-2024 vide item III (17) approved the Syllabus in principle and permitted to publish the same, as and when ready, after making the necessary modifications.

7. The Minutes of the Academic council is approved by the Vice Chancellor.

8. Further, the BoS Political Science, vide paper read 8, rectified certain defects occurred in the Scheme part of the Syllabus and submitted the same for approval.

9.Therefore, Vice Chancellor in tune with the resolution of the Academic Council, approved modification effected in the Scheme & first and second Semester Syllabus of the B.A. Political Science programme (FYUGP) in Affiliated Colleges under Kannur University w.e.f.
