**ORDER**

1. As per papers read (1) above, KU FYUGP Regulations and Curriculum Framework, 2024 was approved and implemented in Affiliated Colleges under the University w.e.f. 2024 admission and certain modifications were effected thereafter vide paper read 2.
2. As per the clause 18.9.15 of the approved Regulation, "students shall secure minimum 30% for End Semester Evaluation and an aggregate of 35% for successful completion of of each course."
- 3.The Examination Branch vide the paper read (3), sought clarification on the matter that whether pass minimum mark is required for theory and practical components separately or considered together , in the case of course having both theory and practical components, and also sought clarification regarding the pass requirements for CCA of both theory and practical components. Also, as per clause 2.18 of the Regulations 'the SGPA shall be rounded off to three decimal places" whereas in clause 22.4.2 of the Regulation it is stated that "SGPA and CGPA shall be rounded off to 2 decimal places'. Therefore, the Examination Branch requested to review the disparity that occurred in the above two clauses also.
5. Subsequently, clarification was sought from the Chairperson and Convenor of Curriculum Regulation Committee of FYUGP and in reply the Convenor furnished clarification as given below
  - a) with respect to the clause 18.9.15, recommended that " in case of ESE, students shall secure a minimum 30%, irrespective of whether ESE has theory, practical or both theory and practical components. In case of total ESE, minimum 30% has to be secured; and in case of cumulative of CCA and ESE minimum 35% is required for successful completion of the course."
  - b) Regarding the Clause 2.18 , it is remarked that " clause 2.18 shall be corrected as "SGPA shall be rounded off to 2 decimal places."
6. Considering the aforementioned remarks furnished by the Convenor, the Vice Chancellor has ordered to place the matter, before the Academic Council.
7. The XXIX th meeting of Academic Council held on 21.12.2024 vide paper read 6 considered the matter and approved the aforementioned remarks furnished by the convenor FYUGP Curriculum Regulation committee with respect to clause 18.9.15 and clause 2.18 of FYUGP Regulation.
8. The Vice Chancellor approved the minutes of the Academic Council and published.
9. Therefore, Regulation of FYUG Programmes implemented in Affiliated colleges w e f 2024



admission is modified by amending the existing clauses 18.9.15 and 2.18 as follows.

**Clause 18.9.15**

*In case of ESE, students shall secure a minimum 30%, irrespective of whether ESE has theory, practical or both theory and practical components. In case of total ESE, minimum 30% has to be secured; and in case of cumulative of CCA and ESE minimum 35% is required for successful completion of the course.*

**Clause 2.18**

**SGPA shall be rounded off to 2 decimal places.**


