ORDER

1. As per paper read (1) above, the Regulations for PG Programmes (CBCSS) under Private Registration 2020 admission were implemented and certain modifications were effected to the same as per paper read (2) above..
2. Clause 13.1 of Regulation of the PG Programme under Private Registration states that ' A candidate securing not less than 40% of aggregate marks of a course with not less than 40% in End Semester Evaluation (ESE) and not less than 10% in Internal Evaluation (IE) separately shall be declared to have passed in that course.
3. As per Clause 13.2 of the aforesaid Regulation, Those who secure not less than 40% marks (both ESE and IE put together) and 40% separately in ESE and not less than 10% in Internal Evaluation (IE) for all the courses of a semester shall be declared to have successfully completed the semester.
4. The Vice Chancellor vide paper read (4) above, considered the matter of modification of regulation of UG/PG Programmes under Private Registration as that of regular programmes without insisting minimum marks for pass in internal marks and ordered to place the same before Academic Council for consideration,
5. The 26th meeting of the Academic Council held on 14/07/2023, vide paper read (5) above, considered the the matter of modification of regulation of UG/PG Programmes under Private Registration as that of regular programmes without insisting minimum marks for pass in internal mark and resolved to approve the same,
6. The Examination Branch vide the paper read (6) above, intimated that the aforesaid Resolution of the Academic Council may be made applicable to 2020 admission UG /PG private registration programmes ,with retrospective effect.
7. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) Chapter III of Kannur University Act 1996 **accorded sanction to modify Clause 13.1 & 13.2 of Regulations for PG Programmes under Private Registration w.e.f 2020 Admission as follows ; Clause 13.1 : A candidate securing E Grade with 40% of Aggregate marks and 40% separately for ESE for each course shall be declared to have passed in that course. Clause 13.2 : Those who secure not less than 40% marks (both ESE and IE put together) for all the courses of a semester**

shall be declared to have successfully completed the semester.

8. Therefore, the U. O. read as paper (1) & (2) above stand modified to this extent..
9. Orders are issued accordingly


