Admission to B.C.A Programme under Private Registration Scheme 2024 – 25

Three Year **B.C.A Programme (FYUGP Pattern)** under Private Registration scheme is offered under Centre for Private Registration of School of Lifelong Learning, Kannur University for the academic year 2024–25, through Payment Integrated Online Registration available on the website www.kannuruniversity.ac.in.

Programme Offered	Bachelor of Computer Application (B.C.A) <i>Three year (Six Semesters) of B.C.A Programme of Private Registration candidates shall be as per the modified regulation and curriculum of Kannur University Four-Year Under-Graduate Programme (FYUGP) Pattern.</i>
Eligibility for admission	A Pass in HSE/ Plus Two or Equivalent Course recognised by respective Boards of Govt. of Kerala or Kannur University <i>(Eligibility/ Equivalency Certificate issued by Kannur University shall be submitted along with the application in the case of courses other than HSE of Kerala/ SSE of CBSE, ICSE, NIOS and Kerala Literacy Mission.)</i> (Minimum intake is 30 and maximum intake is 60)
Fee (₹)	<ol style="list-style-type: none">1. Private Registration Fee : ₹6000/-2. Course fee for practical classes: ₹2000/- per semester3. Postal Charges : ₹70/-4. Matriculation Fee : ₹185/- (ONLY for those enrolling in Kannur University for the first time.)5. Recognition Fee : ₹185/- (ONLY for those who have qualified from Boards/

GENERAL RULES:

- i. Academic eligibility for admission should be satisfied **as on the date of notification.**
- ii. **Three year (Six Semesters) B.C.A Programme** of Private Registration candidates will be as per the modified regulation and curriculum of Four-Year Under-Graduate Programme (FYUGP) Pattern. Regulation and Syllabus of UG Programmes of **FYUGP pattern** for Private Registration candidates will be made available on the university website. As part of UG programmes of FYUGP Pattern, candidates will be required, as per the regulation, to opt General Foundation Courses (AEC, MDC, SEC, VAC), Major Courses & Minor Courses, as per the list of courses published by the School of Lifelong Learning.
- iii. Candidates will be required to register for examination remitting the required fee, as per the notification issued by the Controller of Examinations.
- iv. Continuous Comprehensive Assessment /practical of Private Registration candidates will be as per the regulation and guidelines including fee prescribed by the university from time to time.
- v. **Minimum intake will be 30 and maximum intake will be 60.** If the registered candidates are below the minimum intake (30), B.C.A programme will not be offered and the fee remitted will be refunded in full or the candidates will be permitted to opt for other programmes if they are eligible.
- vi. No Study Materials and Contact Classes will be provided to the Private Registration Candidates. However, limited number of practical classes for B.C.A programme will be offered at the Department of Information Technology, Mangattuparamba for all semesters . **₹2,000/- (Rupees two thousand only) per semester** is fixed as course fee for these practical classes and only those candidates who remit the course fee for practical classes in each semester will be eligible for registration for the End Semester Examination of the respective semester.
- vii. Candidates are permitted to opt **Sree Narayana College, Kannur** only as centre for registration for B.C.A programme under private registration mode for the academic year 2024-25.
- viii. The status of Recognition/Equivalency of Private Registration Programmes will be subject to the orders issued by the Govt. of Kerala/UGC/other appropriate academic bodies from time to time.
- ix. Fee once remitted will not be refunded. However, if the programme is not conducted for want of minimum intake, full fee remitted will be refunded.

1. SUBMISSION OF APPLICATION

- i. Application should be submitted online through payment integrated registration link provided in the website www.kannuruniversity.ac.in
- ii. Payment shall be made online at the time of online registration. Candidates should note down the details of the fee remitted for further reference.

After online submission of the application, the following documents are to be submitted to the **Director, School of Lifelong Learning, Kannur University, Thavakkara, Civil Station P O, Kannur - 670002** on or before **19.09.2024, 4 p.m.**

- a. The printout of the online application (photo self-attested)
- b. Print out of the fee receipt
- c. +2 or equivalent certificate (**original**) along with a self attested photocopy
- d. Transfer Certificate (**original**)
- e. SSLC (self attested photocopy)
- f. Recognition/ Equivalency Certificate issued by Kannur University (Only in the case of those who have passed the Qualifying Examination from other Boards/Universities of other states)
- g. Self-addressed cover (24 cm x 32 cm). (**Residential Address ONLY to be furnished on the cover**)

Note:-

- Candidates are advised to keep scanned copies of their certificates before submitting the originals to University.
- Candidates are advised to avoid lamination of documents submitted by them (if laminated, a square seal size of lamination from the backside of Qualifying Certificate and Transfer Certificate should be removed before submitting the documents to the University).

- Qualifying Certificates and Transfer Certificate will be returned to the candidate, by post, after the private registration is granted. (In case candidates request for return of documents before the private registration formalities are completed, the documents will be returned to them on submission of request along with the service charge)
