Regulations of PG Programmes in Affiliated Colleges w.e.f. 2023 admission - Re-instated Single Valuation system with provision for Revaluation from October 2024 Session onwards -Orders issued

ORDER

1. The revised Regulations for PG programmes in Affiliated Colleges was implemented w.e.f. 2023 admission, vide paper read as (1) above.
2. As per the Clause 7.14 'Revaluation' of the Regulations, *"in the new system, Revaluation is permissible. The prevailing rules and regulations of Revaluation are applicable to KUCBCSSPG2023."*
3. The XXVI Meeting of Academic Council vide paper read (2) above considered the Recommendation of the Senate to amend the existing Regulations of Revaluation of University Examinations and resolved to re-instate the 'Double valuation system' in the PG Examinations and to stop Revaluation and U.O. implementing the Resolution of the Academic Council was issued vide paper read (3) above.
4. Subsequently, as per read (4) above, Double valuation of Answer scripts, without the provision of Revaluation was made applicable for all PG programmes in Affiliated Colleges w.e.f. 2023 admission, including the 8 Programmes where the Syllabuses were not revised in tune with the 2023 PG Regulations.
5. Meanwhile, the Examination Branch, considering the requests received from the Students, Teachers & Principals of Colleges to implement the Single Valuation System for PG programmes, placed the matter of Re-instating the Single Valuation system for PG programmes with the provision of Revaluation, before the Meeting of the Academic Council. Hence, the Resolution No:10 under the Item No:(1) of the Minutes of the XXVIth Meeting of the Academic Council held on 14-7-2023 was placed before the Meeting of the Academic Council, for re-consideration.
6. Subsequently, the XXIXth Meeting of the Academic Council, held on 21-12-2024 vide paper read (5) above, considered the matter and *approved to reinstate Single Valuation system for the PG Programmes in Affiliated Colleges from the October 2024 session onwards, including MBA & MCA.*
7. The Minutes of the Academic Council was approved by the Vice Chancellor and published.
8. Therefore, ***the 'Single Valuation System' is re-instated for all PG programmes in Affiliated Colleges under the University from the October 2024 session onwards, with a provision for Revaluation of Answer scripts.***
9. The U.O read vide papers (3) & (4) above stands modified to this extent.
10. Orders are issued accordingly.
