ORDER

1.The Clause 9.1 (Attendance) of the Regulation for Post Graduate Programmes in the Teaching Departments/ Schools of the University reads that " Condonation of attendance to a maximum of 10 days in a Semester subject to a maximum of two spells within a Programme will be granted by the Vice Chancellor. Benefits of condonation of attendance will be granted to the students on health ground, for participating in University Union activities, meeting of the University bodies and participation in other extracurricular activities on production of genuine supporting documents with the recommendation of the Head of the Department concerned. ***A Student who is not eligible for Condonation shall repeat the course along with the subsequent batch***".

2. As per paper read (2) above, the Senate meeting held on 28.12.2022, passed the Resolution No:4 moved by Sri Shanavas S M, with regard to granting re admission to candidates who are halfway in their studies, for any reason, shall given readmission in the next batch in the same institution, to continue their studies, by allocating additional seats even if there is no vacancy in the batch concerned.

3 . The Vice chancellor, after considering the matter has ordered to place the resolution No.4 passed by the senate in its meeting dated 28.12.2022 , before the Syndicate for consideration and final approval.

4 . Subsequently, the Syndicate held on 28.04.2023, vide Paper read 3 above, considered the Resolution No.4 passed by the meeting of the Senate held on 28.12.2022 with regard to granting re-admission to candidates in the same institution and complete the course, by allocating additional seats even if there is no vacancy in the batch concerned and ***resolved to approve with a maximum limit of 10% of the total seats, over and above the sanctioned strength***

5. The resolution of the Syndicate has been implemented and ***sanction has been accorded for candidates to repeat the course along with subsequent batch in the same institution and complete the course, by allocating additional seats even if there is no vacancy, with a maximum limit of 10% of the total seats, over and above the sanctioned strength.***

6. Hence ***Clause 9.1 of Regulation for Post Graduate Programmes in the Teaching Departments/Schools of the University with respect to repeat the course is modified as per the orders of Vice chancellor as follows: "A Student who is not eligible for Condonation shall repeat the course along with the subsequent batch, in the same institution, by allocating additional seats even if there is no vacancy in the batch concerned, with a maximum limit of 10% of the total seats , over and above the sanctioned strength."***

7 . U.O read (1) above stands modified to this extent
