ORDER

1. As per the papers read (1) to (7) above, Common Course in English and Additional Common Courses in Malayalam, Sanskrit, Arabic, Hindi, Urdu and Kannada for UG Programmes under CBCSS-OBE in affiliated colleges, were implemented w.e.f 2019 admission.
2. After the syllabus revision of UG programmes under CBCSS-OBE in affiliated Colleges in 2019, many new Generation and other UG programmes were introduced in various affiliated colleges w.e.f 2020. Though the Scheme, Syllabus of New Generation programmes were drafted in tune with the existing regulation for UG Programmes under CBCSS-OBE, the respective U.O's implementing such new generation programmes were silent about the Common Courses & Additional Common Courses that are to be opted.
3. As per paper read (8) above, the exam branch has requested to issue specific orders mentioning that the syllabus of Common Course and Additional Common Course for newly introduced programmes are the same as that offered for revised syllabus of UG programmes under CBCSS-OBE w.e.f 2019 admission.
4. The Vice-chancellor after considering the matter in detail and in exercise of the powers of Academic Council conferred under Section 11 (1), Chapter III of Kannur University Act 1996, accorded sanction to implement the existing syllabus of Common Course and Additional Common Courses of UG Programmes under CBCSS-OBE implemented w.e.f 2019 admission, for all UG Programmes introduced thereafter, and shall be effective for all programmes, until the same gets revised, subject to reporting to the Academic Council.
5. The U.O read (1 to 7) above stands modified to this extent
