**ORDER**

1. Applications have been received from some candidates who are undergoing regular programmes under and outside Kannur University seeking admission to private registration programmes.

2. As per the guidelines for pursuing Two Academic Programmes simultaneously vide paper read as (1) above, a student can pursue two full time academic programmes simultaneously one in full time physical mode and another in Open and Distance Learning (ODL)/Online mode offered by departments in other campuses/affiliated colleges in Kannur University and other Higher Education Institutions. The student however cannot be permitted to pursue two regular programmes simultaneously through physical mode under Kannur University.

3. The Syndicate, at its meeting held on 30.09.2024, vide paper read as (2) above, considered and resolved to grant admission to eligible candidates pursuing regular programmes at Kannur University and other Educational Institutions for Private Registration Programmes under School of Lifelong Learning other than those presently undergoing, without producing Transfer Certificate for admission.

4. The above Syndicate resolution has been implemented by the Registrar.

5. Hence, the following orders are issued in this regard, as directed by the Registrar.

i. Candidates pursuing any regular programmes under Kannur University and other educational institutions are eligible to seek admission to private registration programmes under the School of Lifelong Learning other than the programmes they are presently attending, without producing transfer certificate for the purpose of admission at the School of Lifelong Learning, if they possess the minimum eligibility for admission to the private registration programme concerned.

ii. Candidates seeking admission under the above provision shall produce the proof showing the details of the regular programme they are undergoing, at the time of admission at School of Lifelong Learning.

6. Orders are issued accordingly.


