ORDER

1.The Syndicate of the University held on 10/08/2018 resolved to grant one Mercy Chance to improve Internal marks to students of B.A.L.L.B Course.

2.Subsequently, a three member Committee, consisting of the Head of the Department(Law), Chairman, Board of Studies(Law) and Dean(Faculty of Law) was constituted to study and frame the Guidelines for the improvement of the Internal marks of B.A.L.L.B.Examinations and the aforesaid Committee, after detailed discussion submitted the 13 point Guidelines for improvement of Internal marks of B.A.L.L.B Programme vide the paper read(1) above.

3.The Vice Chancellor, while considering the 13 point Guidelines, submitted by the Committee, ordered to delete the Clause No (iv) of the Guidelines prepared by the aforesaid Committee, by which it was recommended that, "The eligibility for improvement of internal marks shall generally be limited to one paper for every semester. Provided that, if any student has not availed the benefit of improving the internal marks in a paper in any semester, the eligibility for the same may be carried forward to any paper in any other semester, subject to a maximum of ten

papers in total". Accordingly, the U.O. was issued vide paper read (2) above, excluding the aforesaid clause. Further, the matter was placed before the Syndicate held on 22/12/2018 for ratification.

4. Likewise, as per the recommendations of the Committee, the matter was reported to the Board of Studies in Law (Cd) also, held on 17/01/2019.

5. The Board of Studies in Law (Cd) recommended vide paper read(4) above, that the deleted clause *"may be reintroduced, to avoid flooding of requests for improvement of Internals on extraneous grounds"*.

6. The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) of Kannur University Act 1996 and all other enabling provisions read together with, approved the aforementioned Minutes of the BOS in Law(Cd) held on 17/01/2019 and accorded sanction to implement the 13 point Guidelines/rules framed by the Committee, for introducing to the B.A.L.L.B course applicable to the students of 2009 Regulations by relaxing the statement "There shall be no chance to improve the internal marks" under the heading "Criteria for Passing Examinations" of the Regulations of B.A.L.L.B Course, implemented w.e.f 2009 admission, as recommended by the Board of Studies in Law (Cd), subject to reporting to the Academic Council and the following Orders are therefore issued.

Students may avail of ONE chance per subject/paper (excluding clinical/practical papers) for improving internal assessment marks, subject to the following conditions:

(i) Re-doing of internals for improvement of marks shall be permitted only after completion of the course. During the course period, no re-doing of internals shall be allowed in any subject in the curriculum.

(ii) The following categories of students shall not be eligible for improvement of internal assessment marks obtained in a subject/paper:

- a. Students who have successfully completed the course.
- b. Students who have secured 50 percent or more marks for internal assessment in the subject/
paper concerned.
- c. Students who have passed the subject/paper concerned.

(iii) An application for improvement of internal assessment marks obtained in a subject/paper by re-doing the same shall be made within one year from the date of written examination in the last subject in the final semester of the course concerned conducted by the University.

Provided that this condition may be waived once, after notification of these guidelines, for students in whose case the one year period has already elapsed.

(iv) The eligibility for improvement of internal marks shall generally be limited to one paper for every semester. Provided that, if any student has not availed the benefit of improving the internal marks in a paper in any semester, the eligibility for the same may be carried forward to any paper in any other semester, subject to a maximum of ten papers in total.

(v) Only one chance shall be allowed for re-doing internals for improvement of internal marks for a student in a particular subject/paper. If the candidate is eligible for re-doing internals for more than one paper/ subject and desires to do so, a single application should be made for the purpose for all the papers.

(vi) Each student who fulfils the above conditions and intends to re-do the internals should make an application to the University and remit the prescribed fee per paper, as fixed by the University. The fee at the prescribed rate for all the papers/ subjects for which the candidate desires to redo internals shall be paid at a single instance.

(vii) On verification of the eligibility of the student for re-doing internals, the University may issue an order to the Department/College/ Institution concerned for the purpose.

(viii) The Head of the department/college/institution, on receipt of the University order, shall make arrangements for re-doing the internals subject to the condition that the teacher who valued the original internal assessment shall not be entrusted with the re-evaluation of the internals.

(ix) The student shall re-do the required components of internal assessment as instructed by the teacher concerned in accordance with Regulations applicable to the candidate concerned. The component of marks for attendance, if any, shall be the marks obtained by the candidate while she attended the semester on a regular basis.

(x) A maximum of 90 working days may be given for completing the internal assessment process by the teacher concerned.

(xi) The revised marks shall be forwarded from the Department/College/Institution to the University within 100 working days from receipt of the University Order.

(xii) Improved internal marks is to be given in the session in which candidate has scored the highest external mark in the subject. (The candidate should submit copy of the mark list along with the application for internal marks improvement).

(xiii) Month and year of passing of the subject as a result of the internal improvement shall be considered as the month and year of passing the subject and reflected in the mark sheet accordingly.

The U.O cited (2) above stands modified to this extent.
