CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Kannur University Teacher Education Centre, Dwarakanagar, Kasaragod District, Pin-676612, Kerala** vide order no. F.KL/SEC/N/362/SRO/NCTE/2005-2006/2326 dt. 09.08.2005 for Secondary (B.Ed.) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 10.04.2015 for its willingness for B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 27.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 Students (two basic units of 50 students each) from the academic session 2015-16**

3. **AND WHEREAS**, the SRC in its 320th Meeting held on 19th & 20th September, 2016 has considered the matter and decided to issue a letter to the institution. Accordingly, as per the decision of SRC a letter was issued to the University for returning of Demand Draft for revalidation-reg dt. 05.09.2017. The institution has submitted a written representation dt. 30.10.2017

4. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 and 387th meeting held on 24th – 25th August 2020 has considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 16.09.2020. The institution has submitted reply of Show Cause Notice vide letter dt. 15.03.2022.

5. **AND WHEREAS**, the SRC in its 410th Meeting held on 25th & 26th April, 2022 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 12.05.2022. The institution has submitted a written representation on 13.06.2022.

6. **AND WHEREAS**, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 has considered the matter and decided to issue Last reminder (Letter) to the institution. Accordingly, as per the decision of SRC Last reminder (Letter) was issued to the institution on 05.09.2022. The institution did not submit any reply to Last reminder (Letter).

7. **AND WHEREAS**, the SRC in its 425th Meeting held on 18th May, 2023 has considered the matter and decided to Withdraw the recognition granted to the institution. Accordingly, as per the decision of SRC, Withdrawal Order No. F.SRC/NCTE/APSO2520/B.Ed./425th Mtg/KL/2023/142137-142140 dt. 26.05.2023 was issued to the University for B.Ed. programme.

8. **AND WHEREAS**, aggrieved by the order of the SRC, the University preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. 89-128/E-311800/2023 Appeal/9th Meeting, 2023 APPLSRC202314638/121425 dt. 12.09.2023 appeal remand back the case to SRC with a direction to consider the documents. The institution has submitted reply of appeal remand back case dt. 15.09.2023.

9. **AND WHEREAS**, the SRC in its 430th Meeting held on 01st December, 2023 has considered the matter and decided as follows: -

“The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the institution **Kannur University Teacher Education Centre, Survey No. 300/302, Chala Road, Vidyanagar PO, Kasaragod, Kerala-671123 for B.Ed. programme for 1 basic unit of 50 students.**”*

10. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Kannur University Teacher Education Centre, Survey No. 300/302, Chala Road, Vidyanagar PO, Kasaragod, Kerala-671123** for Continuation of recognition for **B.Ed. programme** of two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

14. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



15. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

18. The institution shall make available the list of students admitted on its official website.

19. The institution shall fill the information on GIS Portal on the NCTE Website.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, the institution **Kannur University Teacher Education Centre, Dwarakanagar, Kasaragod District-676612, Kerala** has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities

3. **AND WHEREAS**, on scrutiny it is found that the reply of the institution dated 28.03.2015 in respect to the Show Cause Notice is pending with this office. Revised order issued is subject to the decision of the committee on the reply pending before SRC.

4. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

5. **NOW THEREFORE**, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Kannur University Teacher Education Centre, Dwarakanagar, Kasaragod District-676612, Kerala** for conducting **B.Ed** programme of **two** years duration with an annual intake of **100** for two basic units of 50 students each from the academic session **2015-16**.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
