ORDER

1.The Regulations, Scheme,Syllabus & Model Question Papers of the Two year Bachelor of Education (B.Ed.) Degree Programme in tune with NCTE Regulation 2014 was implemented in the Kannur University with effect from 2015 admission as per paper read (1) above and certain modifications were effected to the same vide paper read (2).

2.As per the Clause 22- Classification of Successful Candidates - Sub clause (c) second para of the Regulations, 'if candidate fails to secure minimum for pass, he/she shall be permitted to re appear for the course examination. But there will be no supplementary examination. For reappearance/improvement, the students can reappear along with the next Batch'.

3.The Regulations of the B.Ed. programme (2015), is silent with regard to re- appearance/ improvement of EPC [Enhancing Professional Competencies] Courses & Practical Examinations.

4.Hence, the Examination Branch, vide paper read (3) above, requested to consider the matter of framing rules for re-appearance of EPC [Enhancing Professional Competencies] Courses and Practical Examinations of the B.Ed. Degree programme (2015).

5. Subsequently, the meeting of the BoS in Education(Cd), held on 05.02.2020 entrusted Dr. Faisal K.V, Asst. Professor, Keyi Sahib Training College, to frame rules for the re-appearance of EPC Courses and Practical Examinations of B.Ed Degree Programme (2015).

6.Thereafter, Dr. C K. Babu (the then Chairman of Board of Studies in Education Cd) submitted the rules framed regarding the re-appearance of EPC Courses/ Practical Examinations of B.Ed. Degree programme (2015).

7. As the term of office of Board of Studies had expired in due course of time, remarks of the Dean was sought on implementation of the aforesaid rules and the same was ratified by the Dean, Faculty of Education as per paper read (6).

8.The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council, conferred under section 11 (1) Chapter III of Kannur University Act 1996, approved the Guidelines for the re-appearance of EPC [Enhancing Professional Competencies] Courses/Practical Examinations, and to modify the Regulations of the B.Ed.programme (2015) as follows, subject to reporting to the Academic Council.

9. The last Para of the Subclause (c) regarding the failure of a candidate to secure minimum for a pass under Clause 22 - 'Classification of Successful candidates' in the Regulations of the two

year B.Ed.programme (implemented w.e.f.2015 admission), is modified incorporating the following.

10. (c(i)-the new clause incorporated-) **If a candidate fails to secure minimum for pass in EPC Course/Practical, he/she has to re appear for the same along with the EPC Examinations/Practical of a successive batch. No separate Examination/Practical shall be made for a single or group of candidate.**

11. **The examination shall be conducted subject to the Guidelines appended with this U.O.**

12. The U O read vide (1) above stands modified to this extent.

Norms Regarding the Reappearance/ Improvement of EPC Courses/ Practical Examinations of B.Ed Programme

As per B Ed Regulation and Guidelines, of Kannur University, there is no improvement chance for EPC Courses and Practical Examinations.

Therefore it is suggested that in case a candidate fails to secure minimum for pass in EPC Course/Practical, he/she has to re appear for the same along with the EPC Examinations/Practical of a successive batch. No separate Examination/Practical shall be made for a single or group of candidates.

The candidate shall pay fee for re-registration Rs.2000/- and fee for each paper as fixed by the Examination Branch of the University.

The Head of the institution can sanction the candidate for reappearing if only he/she has convinced the genuine nature of the case.

The Following instances may be encountered by a prospective teacher.

- **He /She has completed all the required tasks including teaching practice, but couldn't attend the Practical examination due to some personal reasons-- he/she may be permitted to attend the exam in the subsequent year in the same or convenient centre**
- **Delaying in the completion of tasks and submission of required records, but completed teaching practice successfully-- he/she can attend the Exam in the subsequent year in the same or convenient centre.**
