**ORDER**

1. The Regulation, Scheme and Syllabus of B.A Malayalam, B.A Political Science, B.A English, B.A Afzal-UI-Ulama, B.A Economics, B.A History, BBA & B.Com programmes under the Private Registration(2020) was implemented as per the papers read (1) to (9) respectively.
2. As there is no provision to conduct Internal Evaluation of Project work for the Programmes under Private Registration, the Director School of Distance Education requested as per paper read (10) above, to discard the internal component of Project work of B.A Malayalam, B.A Political Science, B.A English, B.A Afsal-UI-Ulama, B.A Economics & B.A History programs w.e.f 2020 admission and to issue detailed guidelines for the preparation and submission of the Project Reports.
3. As all activities of the reconstituted Board of Studies are kept in abeyance in the light of the judgement in WA No.1530/2021 Dated 22.03.2022, the Vice chancellor ordered to conduct a meeting of the former Chairpersons, Board of Studies in Malayalam, Political Science, Economics, History, Arabic (UG ) and English (PG) and officials concerned from School of Distance Education & Examination Branches for considering the same.
4. The meeting of former Chairpersons of Board of Studies (2018-20) of the respective subjects, held on 04.01.2023 recommended the following with regard to evaluation and submission of the Project in VI<sup>th</sup> semester of all UG private registration programmes w.e.f 2020 admission, as per paper read (11) above.

1. Evaluation of the Project in VI<sup>th</sup> semester of all UG programmes under Private Registration effective from 2020 admission be made externally without the components of Viva Voce, Tour Report and Field Visit/Study. There will be no internal assessment as part of Project work, and the marks earmarked for internal evaluation as per the existing scheme and syllabus be reallocated as External Evaluation with same credits, as given below.
